This new park enhancement will feature monuments telling the stories of local veterans through images. Four sections of the park will focus on each century of conflicts through America's history. These images will be selected by a committee of local community members. The committee is requesting family and friends share personal veteran stories and images (must have image ownership rights). Selected images will be used on the memorials throughout the park. If you have a picture or image related to a veteran who was a resident of Clark County at any point of their life, please send the completed forms to National Trail. Acceptable submissions are listed below. In addition, all submissions, used or unused in the Redevelopment Project, will be preserved at the Clark County Historical Society. It will also be added to the park archives and possible future Veterans Park exhibits.

Make a copy of your photo. National Trail does not want original photos and cannot be responsible for returning photos to donors. If your image is selected the committee will need to use the original photo for engraving process. It will be returned to the owner. Deadline for submissions is November 11, 2017.
