The NTPRD does hereby lease unto the LESSEE, upon the terms and provisions hereinafter set forth, Splash Zone located at 300 Eagle City Road, Springfield, Ohio. LESSEE agrees to pay the NTPRD as rent for the use of this facility the appropriate fees set forth herein. The NTPRD will provide the services of lifeguards during the date/time of the event. LESSEE agrees to abide by the NTPRD's regulations for said facility and, upon termination of this Agreement, agrees that it will surrender and deliver to NTPRD said facility in as good a condition as it was prior to occupancy. The NTPRD reserves the right to terminate this Agreement if any damages or improper use of the pool occurs during the time the LESSEE is using the Splash Zone or at the NTPRD's convenience for any reason. LESSEE shall assume the costs of any damages that may be occasioned to said facility during the time of Agreement and hold harmless CITY OF SPRINGFIELD / NTPRD / CLARK COUNTY COMMISSION from any and all claims that might occur as a result of said LESSEE's occupancy. The LESSEE shall not have the authority to sublease the Splash Zone.

Rental Information:

- All rules and regulations apply during private parties.
- Parties must provide onsite point of contact for Splash Zone Staff to communicate issues and concerns.
- With approval, outside food and beverages are permitted in the park area after 7:00 pm.
- Alcohol or glass containers are not permitted in park.
- If concession stand is open, outside food will not be permitted to be brought into park area.

Weather Policy:

Every attempt will be made to have rental as scheduled. If weather is questionable, the decision to cancel and reschedule will be made by NTPRD Splash Zone staff by 3:00pm. A refund will only be issued if NTPRD Splash Zone staff determines a rain date reschedule is not possible.
